The applicant is not pressing prayers (a) and (b), the prayer (c) which is consideration of his representation dated 30.10.2024 and 21.11.2024. By Memo No. 950 dated 30.10.2023, the applicant was appointed to the post of Sub Inspector of Police (Unarmed Branch) in West Bengal Police. By an Order No. 1302 dated 22.10.2024 issued by the DIG/Vice Principal, Swami Vivekananda State Police Academy, West Bengal, Barrackpore, the applicant was discharged from Police Service. The relevant portion of which is as under :-

".....undergoing 12 months residential Basic Training of Cadet Sub-Inspectors (Un-armed Branch), is hereby discharged from Police Service w.e.f. 22/10/2024 AM as he is unsuitable for becoming an efficient police officer as subinspector of police due to his continuous absence from training and failure to comply with orders issued by the competent authority in the Academy from time-to-time. This Order is issued in accordance to Para 3 & 4 of memo no. 950/RO dated 30.10.2023.......".

Mr. Sanyal appearing on behalf of the applicant submits that due to serious family issues, he could not attend the training regularly. Praying before the Inspector General of Police, Swami Vivekananda State Police Academy, West Bengal, Barrackpore, he has requested for consideration of the order No. 1302 by

which he was discharged from service.
