Mrs. S. Agarwal, learned advocate appears on behalf of the State respondents. However, she has not received her appointment. Let Legal Remembrancer, West Bengal is directed to regularise the appointment of Mrs. Agarwal.

In the instant application, Basudeb Show - the applicant has prayed for compassionate appointment. The father of the applicant Saranan Show, Krishi Proyukti Sahayak under Mangaldihi Gram Panchayat, Ilambazar Block, expired on 18.02.2014. The applicant was 33 years old at the time of the death of his father and within the time limit applied for a compassionate appointment on 09.04.2014. Thereafter, three men enquiry committee was formed on 17.06.2014. The Assistant Director of Agriculture (Admn.), Bolpur, Birbhum submitted the proposal for appointment of Basudeb Show proposing the post of Group – D (Night Guard) on 27.07.2015. Again on 03.02.2020, the Deputy Director of Agriculture (Admn.), Birbhum submitted the proposal to the Director of Agriculture & Ex-officio Secretary, Department of Agriculture, Government of West Bengal in favour of Basudeb Show to a post of Group –D (Night Guard) in the office of the Asst. D. A., Khayrasole Block under the establishment of Assistant Director of Agriculture (Admn.), Suri (Sadar) Sub-Division.

However, the learned advocate for the applicant submits that no further information has been received from the respondents regarding this matter. He submits that the Tribunal may issue suitable direction to the respondents to dispose of the matter at the earliest.
