The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 638-WBAT/2J-15/2016 (Pt.-II) dated 23rd November, 2022 issued in exercise of the powers conferred under Section 5 (6) of the Administrative Tribunals Act, 1985.

On consent of the learned counsels for the contesting parties, the case is taken up for consideration sitting singly.

Learned counsels appearing on behalf of the applicant are emphatic that the entire disciplinary proceedings was concluded with serious procedural lapses. As instances, the following deviation have been pointed out:

- (i) A copy of the enquiry report was not served upon the Charged Officer, the applicant.
- (ii) The advise of the Public Service Commission was not obtained, if obtained, no copy of such advise of the Commission was served upon the Charged Officer.
- (iii) The District Programme Officer (ICDS) Darjeeling being the Presenting Officer in this proceeding also acted as a witness.

The Tribunal having heard the submissions and after examining the
