The matter is taken up by the single Bench pursuant to the order contained in the Notification No. 118-WBAT/1E-08/2003 (Pt.-II) dated 11th February, 2022 issued in exercise of the powers conferred under section 6(5) of the Administrative Tribunals Act, 1985.

Affidavit of service filed be kept on record.

Since despite service of notice none appears on behalf of the State respondent, Mrs. Sonali Mitra, learned advocate, who normally appears on behalf of the State respondents, is requested to appear in this matter. Let a copy of this original application be served on Mrs. Mitra, which is served and accepted. The Legal Remembrancer, West Bengal is directed to regularise the appointment of Mrs. Mitra.

In the application Bikram Gangaputra and Suraj Dam, the applicants have prayed for a direction upon the respondents to pay the enhanced monthly remuneration to them and to allow them to work as Dome in Jangipur Police Morgue and not to disturb their services as casual workers and to pay the arrear remuneration.

It is submitted that though letter dated 28<sup>th</sup> April, 2021 was furnished before the authorities demanding justice it has not been considered. Aggrieved this application was filed.

Mrs. Mitra, learned advocate appearing on behalf of the State respondents submits, if directed, the respondent authority will consider

the matter in accordance with law.

Since it appears that the applicants are carrying on their services as Dome and they have claimed that they are entitled to higher remuneration as evident from the prayers, considering the said fact, the application is disposed of by granting liberty to the applicants to furnish representations separately ventilating their grievances before the Director of Health Services, West Bengal, - the respondent no. 3 within four weeks along with copies of this order downloaded from the website of the Tribunal.

If such representations are filed, same shall be disposed of separately by the respondent no. 3 by passing reasoned orders within fifteen weeks to be communicated to the parties, after giving an opportunity of hearing, after considering the circulars and notifications covering the field and after making necessary enquiry.
