In this application, Ranjan Kumar Dey, the applicant, has joined the transferred post, has prayed for certain reliefs, the relevant portion of which is as under :-

*“(a)A mandatory direction do issue upon the concerned respondent authorities, particularly upon the Additional Director, Public Instruction (Administration), West Bengal thereby revoking /quashing and/or setting aside the impugned cryptic transfer order being Memo No. 59-A87-2 a/2014 dated 18.01.2021 along with Memo No. 27/DA dated 16.08.2021 and issue a fresh order towards permitting the instant applicant to continue the discharge of his duties at his erstwhile place of posting.*

*(b)A direction do issue upon the respondent authorities to dispose of the communication of the applicant dated 11.08.2021 and thereby grant the request he has made therein.....”.*

Though several prayers have been made challenging his order of transfer, however, it is submitted by Mr. S.N. Ray, learned advocate for the applicant that in the interest of justice, direction may be issued upon the Additional Director of Public Instruction (Administration), Education Directorate, Government of West Bengal, - the respondent no. 7 to consider the representation dated 11th August,

It is made clear that we have not gone into the merits of the matter and all points are kept open to be dealt with by the respondent no.7.
