The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 638-WBAT/2J-15/2016 (Pt.-II) dated 23rd November, 2022 issued in exercise of the powers conferred under Section 5(6) of the Administrative Tribunals Act, 1985.

On consent of the learned counsels for the contesting parties, the case is taken up for consideration sitting singly.

The prayer in this application is for a direction to the respondent authority to grant Trainee Reserve to undergo the GNM Course-2022. In this regard, the applicant had submitted applications before the respondent authorities on 03.09.2022. Submission of Mr. G.P. Banerjee, learned counsel for the applicant is that despite such representations, the respondent authorities have neither granted nor communicated their decision to the applicants.

Submission of Mr. Banerjee is that the authorities may be directed to consider the applicant's prayer for Trainee Reserve in the light of judgement passed by this Tribunal in OA-44 of 2023 in the matter of Moumita Majhi Vs. State of West Bengal & Ors.

In response to the above submissions, Mr. Mondal submits that it will be futile to grant the Trainee Reserve to the applicant at this stage since the classes for the course has already been commenced since December, 2022.

After hearing the submissions of the learned counsels, the Tribunal is of the view that since the applicants had furnished a plain paper application before the Respondent No. 2, Director of Health Services (Nursing) on 03.09..2022, it is the responsibility of the respondent authorities to have considered such applications furnished by the applicants. Accordingly, the Respondent No. 2, Director of Health Services is directed to consider the application for Trainee Reserve submitted by the applicants before him on 03.09.2022 in terms of the order passed by this Tribunal in OA-44 of 2023 after considering the eligibility criterias of the applicants as per rule and ascertaining with the Principal, NTC, ESI, Manicktala if her admission is still valid or not. Such decision be taken within six weeks from the date of communication of this order.

Accordingly the application is disposed of.
