The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 638-WBAT/2J-15/2016 (Pt.-II) dated 23<sup>rd</sup> November, 2022 issued in exercise of the powers conferred under Section 5(6) of the Administrative Tribunals Act, 1985.

The prayer in this application is for a direction to the Respondent authorities to expedite the process for offering an appointment on compassionate ground. The father of the applicant, Santosh Mandal died on 22.04.2012 working as Resham Karmi. Mrs. Das, learned counsel submits that though he was appointed as a Resham Karmi but, subsequently he was absorbed in regular establishment as a Group 'D' employee. As per the applicant in his application, soon after death of his father on 22.04.2012, he submitted an application on 20.08.2012 before the S.D.F. Basilardanga (Farm), Basilardanga, Maynaguri, Jalpaiguri praying for employment under compassionate ground. Such plain paper application was followed by the submission of the filled up proforma application dated 11.10.2012 which was acknowledged with the seal and signature of Demonstrator, SDF, Basilardanga, Maynaguri, Jalpaiguri. Copy of the correspondence No. 1422 dated 22.01.2024 throws some light that such an application was being examined by the office of the Respondent authorities.

Submissions of the learned counsels representing both the sides is that, in the meantime, the Finance Department has communicated its views to the Agriculture Department relating to such matters of compassionate employment for the legal heirs of Resham Karmis, who were earlier absorbed in the post of Group-D. Since this case is also covered with the above statement, let it be
