The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 638-WBAT/2J-15/2016 (Pt.-II) dated 23rd November, 2022 issued in exercise of the powers conferred under Section 5 (6) of the Administrative Tribunals Act, 1985.

Affidavit of service filed, be kept with the record.

From the submissions of the learned counsels, it appears that the applicant had superannuated on 31.08.2010 holding the post of Asstt. Project Officer under Mass Education and Extension Deptt. Having superannuated, the applicant continued to receive her pension which was sanctioned by P.P.O. No. SD -277 dated 29.09.2010. Learning of a similar matter in which this Tribunal had passed a favourable order in favour of a person who also superannuated holding similar post. Now she has approached this Tribunal by filing this application and challenging the P.P.O.

Mr. Mitra, representing the Principal Accountant General points out that his office issues a P.P.O. for pensionary benefits against a proposal furnished by the Pension Sanctioning Authority in which the pay structure of the employee is taken into consideration. He also points out that the applicant has only prayed for setting aside the P.P.O but has not challenged the pay fixed in the proposal submitted by the Pension Sanctioning Authority before the Principal Accountant General.

Mrs. Agarwal finds that this application is barred by limitation
