# Vs. THE STATE OF WEST BENGAL & ORS.

In this application, Asim Kumar Karfa, the applicant, has prayed for certain reliefs, the relevant portion of which is as under :-

"A. An order do issue by directing the respondents concerned to fix the pay of the applicant in the post of Revenue Inspector and Revenue Officer and by granting the yearly increment and to forward the papers and documents to the appropriate authority for the retirement benefits of the applicant by taking into account the scale of pay by fixing in the post of Revenue Inspector and Revenue Officer and to pay the balance arrear of salary of the applicant at an earliest date.

B. An order to issue by directing the respondents to pay interest @ 18% per annum on the amount of financial benefits for the delayed period....".

Since it is evident from the memo dated 30<sup>th</sup> September, 2021 and the intimation dated 25<sup>th</sup> November, 2021 that the claim of the applicant for arrear salary and consequential pension have been accepted, considering the said fact, the application is disposed of by directing the Additional District Magistrate & District Land and Land Reforms Officer, Purba Bardhaman, - the respondent no. 2(v) to issue direction for release of the necessary amount due to the applicant as apparent from the annexures to the supplementary affidavit within a period of fifteen weeks from the date of presentation of a copy of this order downloaded from the internet/website of the Tribunal along with interest at the rate of six per cent per annum to be calculated from the date of entitlement.
