The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 638-WBAT/2J-15/2016 (Pt.-II) dated 23<sup>rd</sup> November, 2022 issued in exercise of the powers conferred under Section 5 (6) of the Administrative Tribunals Act, 1985.

On consent of the learned counsels for the contesting parties, the case is taken up for consideration sitting singly.

The applicants have prayed for a direction to the respondent authorities to promote them to the post of U.D.C.

Submission of Mrs.S.Agarwal, learned counsel for the applicant is that the respondents have cited the reasons for not granting the promotion due to pendency of OA-587 of 2016 for promotion in this Tribunal. The applicants have also added the Private respondent - Santana Das. Santana Das after being promoted to the post of U.D.C. had joined the District of Murshidabad where the applicants work.

Since S.Das, U.D.C. had joined on promotion, the Tribunal is not satisfied why she has been added in this application as a private party. The posting of the private respondent on promotion to Murshidabad has no relevance to the prayer of the applicants in this application which is for their own promotion to the post of U.D.Cs. It is and accepted service
