The representation speaks about his brother's illness and his need to be posted at Calcutta, so that he can look after his brother. As submitted by Mr. G.P. Banerjee, learned counsel for the applicant he has not been confirmed in the cadre of WBA&AS and was on lien from the Co-operation Department for 2 years.

Mr. Banerjee, prays for a direction to the respondent No. 2 so that his representation can be considered.

After hearing the submissions and considering the facts and
