The matter is taken up by the single Bench pursuant to the order contained in the Notification No. 496-WBAT/1E-08/2003 (Pt.-II) dated 4<sup>th</sup> August, 2022 issued in exercise of the powers conferred under section 6 (5) of the Administrative Tribunals Act, 1985.

At the very outset Mr. I. Pal, learned advocae appearing on behalf of the applicant submits that leave may be granted to add Inspector General of Police (Administration), Government of West Bengal, Department of Home and Hill Affairs, Nabanna, Howrah, - as added respondent no. 2(vi).

Leave granted.

Since Mr. G.P. Banerjee, learned advocate accepts service of notice on behalf of the added respondent no. 2(vi), no further copy of the application be served on the added respondent.

In the application, Sk. Md. Enamul Karim, presently Sub Inspector of West Bengal Police, has prayed for certain reliefs, the relevant portion of which is as under:

"(a)....An order to respondent authorities specifically the respondent no. 01 to consider the Prayer of the Applicant for Grant of the Notional Service Benefits and Consequential Benefits from the Date of the Promotion of the Juniors and Batch Mates of Applicant in the Post of Sub Inspector in West Bengal Police in accordance with the prevailing laws as earliest."

It appears that during his posting at Mayureswar Police Station

under the Birbhum DPF as Assistant Sub Inspector, the applicant was charged with the allegations of gross misconduct, insubordination, for unprofessional conduct and serious dereliction of duty unbecoming of a member of a Accordingly, departmental proceeding, being District disciplined force. Proceeding No. 04/16, dated 23<sup>rd</sup> February, 2016 was initiated against him. Charges were framed which were denied by written statement filed by the applicant. Finally, the Enquiry Officer passed an order on 29th May, 2018 acquitting the applicant from all the charges which was confirmed by the Superintendent of Police, Birbhum by issuing the final order dated 6<sup>th</sup> June, 2018. The grievance of the applicant is since he has been acquitted of all the charges which has been confirmed by the higher authorities and he has been promoted to the rank of Sub Inspector, however as his juniors and batch mates who have been promoted to the post of Sub Inspectors in West Bengal Police on or after 29th December, 2016, have been granted consequential service benefits, appropriate order may be passed directing the respondents to grant notional service benefits and consequential service benefits to the applicant from the date of promotion of his juniors and batch mates of the applicant in the post of Sub Inspector of West Bengal Police.

It is submitted by Mr. Pal that though a letter dated 26<sup>th</sup> August, 2021, praying for grant of notional and consequential benefits, was issued on behalf of the applicant to the Director General and Inspector General of Police, Department of Home and Hill Affairs, Government of West Bengal, it has not been considered. Aggrieved the application has been filed.

Mr. Banerjee submits, if directed, the State respondents will consider the matter in accordance with law.

Having heard the learned advocates for the parties and considering the facts and circumstances of the case, the application is disposed of by granting liberty to applicant to file representation afresh ventilating his grievances before the Inspector General of Police (Administration), Government of West Bengal, Department of Home and Hill Affairs, Howrah, - the added respondent no. 2(vi) along with a copy of this order downloaded

If representation is filed, same shall be disposed of by the Inspector General of Police (Administration), Government of West Bengal, Department of Home and Hill Affairs, - the added respondent no. 2(vi) by passing a reasoned order to be communicated to the parties within eight weeks after giving an opportunity of hearing and after verifying the records.
