*II) Appropriate order be passed directing the concerned respondents to consider the representation dated 03.06.2021 and the application for transfer dated 07.03.2020 made by the applicant in prescribed format.*

It is submitted by Mr.Ghosh since the representation dated 3<sup>rd</sup> June, 2021 was furnished before the Director of Health Services, Government of West Bengal, the respondent no.2 praying for transfer from Ramnagar Bachra PHC to Ramnagar PHC or Bagula RH in the Nadia District, appropriate order may be passed in the light of memo. dated 23<sup>rd</sup> April, 2021.

Mr.Banerjee, submits if directed, the respondent authorities will consider the matter in accordance with law.

Having heard the learned advocates for the parties and considering the facts and circumstances of the case, the application is disposed of by directing the Director of Health services, Government of West Bengal, the respondent no.2 to dispose of the representation dated 3<sup>rd</sup> June, 2021 filed by the applicant praying for transfer from Ramnagar Bachra PHC to Ramnagar PHC or Bagula RH in the Nadia District being Annexure- P7 to the application, by passing a reasoned order to be communicated to the parties within fifteen weeks from the date of presentation of a copy of this order downloaded from the website of the Tribunal after giving an opportunity of hearing, after verifying the records and after making necessary enquiry.
