The matter is taken up pursuant to the order contained in the Notification No. 638-WBAT / 2J-15/2016 (Pt.-II) dated 23<sup>th</sup> November, 2022 issued in exercise of the powers conferred under the Administrative Tribunals Act, 1985 and the Rules framed thereunder.

On consent of the learned counsels for the contesting parties, the case is taken up for consideration sitting singly.

In terms of the order dated 18.01.2022, the learned counsel for the State respondents has submitted a fresh reasoned order passed on 24.11.2022. A copy of the same be kept on record.

A copy has also been served and received by the learned counsels for the applicant.

Learned counsel for the applicant prays for extension of the interim order passed in O.A. 627 of 2022 on 27.09.2022.

The interim order was a direction to the respondents not to proceed with the notifications dated 28.07.2022 and 19.08.2022 till passing of the fresh reasoned and speaking order.

On perusal of these two notifications, it appears that the dates mentioned are incorrect. The same should have been No. 1534-Estab(Dte) dated 29<sup>th</sup> June, 2022 signed by Shri S. Mukherjee, Addl. Secretary to the Government of West Bengal and No. 1710-Estab(Dte) dated 15<sup>th</sup> July, 2022 signed by the Addl. Secretary to the Government of West Bengal. Both the notifications were issued by the Form No.
