The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 638-WBAT/2J-15/2016 (Pt.-II) dated 23rd November, 2022 issued in exercise of the powers conferred under Section 5(6) of the Administrative Tribunals Act, 1985.

On consent of the learned counsel, the case is taken up for consideration sitting singly.

Affidavit of service filed be kept on record.

The applicant has prayed for setting aside the impugned letter dated 17.02.2020. This letter regrets the proposal for employment under compassionate ground to the applicant as she had crossed the age limit of 40 years at the time of the death of her deceased husband, Debashis Mukherjee.

Submission of Mr. Tewari is that though the applicant had crossed the age limit of 40 years but the Notification No. 1267-F(P) dated 10.02.2012 clearly allows the Head of the Department to condone any excess in age for appointment on compassionate ground. Submission is that the respondent authority did not exercise such discretion in this matter and the proposal for appointment under compassionate ground was rejected. Mr. Tewari prays for liberty to allow the applicant to furnish a fresh representation before the Respondent No. 1, Secretary, Public Works Department requesting condonation of the excess in age of the applicant by exercising the discretionary powers as stipulated in Memorandum No. 1267-F(P) dated 10.02.2012.

After hearing the submission of the learned counsel, this application is disposed of by giving liberty to the applicant's side to furnish a fresh representation praying for condonation of excess age before the Secretary, Public Works Department. Let such a representation be filed before the Respondent No. 1, Secretary, Public Works Department along with copy of this order and copy of the Memorandum No. 1267-F(P) dated 10.02.2012. If
