In this application, Amaresh Roy, the applicant, who had applied for the post of constable in the recruitment process of West Bengal Police 2020, has prayed for several reliefs which are as under:

- "(a) An Order may be passed directing the Respondents to issue admit card to the petitioner for appearing for the said preliminary written test for recruitment to the post of constables and lady constables in West Bengal Police 2020 to be held on and from 26<sup>th</sup> September, 2021 to 29<sup>th</sup> September, 2021.
- (b) To pass such order or further order or orders as Your Lordships may deem fit and proper."

The matter was taken up for hearing on 24<sup>th</sup> September, 2021 when after hearing the learned advocates for the parties, an interim order is passed, the relevant portion of which is as under:

"....Let there be an interim order directing the respondents to allow the applicant to appear in the written examination for the post of Constable in West Bengal Police 2020 scheduled to be held on 26<sup>th</sup> September, 2021 without prejudice to the rights and contentions of the parties and subject to further order that may be passed. After the examination the answer script of the applicant shall be kept in a sealed cover and the result be not published without the leave of the Tribunal...."

Thereafter, directions were issued for filing reply. Reply has been filed which is on record. It is submitted by Mr. Subrata Bhattacharjya, learned advocate for the applicant that as pursuant to the interim order passed by the Tribunal, admit card was issued to the applicant for appearing in the preliminary written test for recruitment and thereafter, the applicant had appeared in the said test, direction may be issued upon the respondents to publish the result.

Mr. M.N. Roy, learned advocate appearing on behalf of the state respondents submits since pursuant to the interim order the applicant has taken part in the preliminary written test for recruitment to the post of the constable, nothing remains to be decided in the application and if directed, the result of the applicant will be published.

Having heard the learned advocates for the parties and considering the facts and circumstances of the case, the application is disposed of by directing the West Bengal Police Recruitment Board and its Chairman, the Respondent Nos. 3 & 4 respectively, to publish the result of the applicant for the preliminary written test for recruitment to the post of constable within a fortnight from the date of presentation of a copy of this order downloaded from the website of the Tribunal.
