The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 638-WBAT/2J-15/2016 (Pt.-II) dated 23rd November, 2022 issued in exercise of the powers conferred under Section 5 (6) of the Administrative Tribunals Act, 1985.

On consent of the learned counsel and the learned Departmental representative for the contesting parties, the case is taken up for consideration sitting singly.

No.28 dated 06.08.2020 addressed by the Officer-in-Charge, Regional Institute of Printing Technology, Kolkata to the Director of Technical Education and Training is noteworthy, the relevant line in this correspondence is as follows:
