The instant application has been filed by one of the married daughter of the deceased employee Late Sunil Kumar Das. The mother of the applicant was pre-deceased of the Ex-employee.

As per the applicant, there are two married sisters and one brother as legal heir. Therefore, she is praying for 1/3rd of the share of the Death-cum-Retirement benefit of the deceased employee. In this regard she had already submitted a representation before the Assistant Engineer, R.W.S, Alipore Sub Division, P.H.E. Dte. on 27.04.2018 which was received by the authority on the same day.

During the course of hearing, the counsel for the applicant has submitted that it would suffice her purpose, if the Respondent No. Ii), Superintending Engineer, South 24 Pgs. Water Supply Circle, P.H.E. Deptt. be directed to consider the case of the applicant and to disburse the said amount as per rules within a stipulated period of time.

The counsel for the respondent has no objection to consider the case of the applicant as per rules.

In view of the above, Respondent No. Ii) Superintending Engineer, Water Supply Circle, South 24 Pgs, P.H.E., Dte. is directed to consider the representation of the applicant as per rules with follow up action after granting an opportunity of personal hearing and to communicate his decision by way of reasoned and speaking order within a period of twelve weeks from the date of receipt of the order. Accordingly, OA is disposed of with no order as to costs.
