The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 638-WBAT/2J-15/2016 (Pt.-II) dated 23<sup>rd</sup> November, 2022 issued in exercise of the powers conferred under Section 5(6) of the Administrative Tribunals Act, 1985.

On consent of the learned counsel, the case is taken up for consideration sitting singly.

Affidavit of service filed on behalf of the applicant be kept on record.

Vakalatnama filed on behalf of the Pvt. Respondent Nos. 4 & 5 be also kept on record.

The applicant has prayed for a direction to the Public Service Commission to publish the list of selected empanelled candidates with their marks and OMR sheets.

An Examination was conducted by the Commission to recruit candidates for the post of Sub-Inspector of Schools under the School Education Department in the year 2018. The contention of this applicant is that though he had scored higher marks but was not recommended, on the contrary, the two private respondents in this application, having scored lower marks to him were recommended for such selection.

The Tribunal is not satisfied that how the applicant had come to know about the marks he had obtained as well the private respondent nos. 4 & 5. The applicant had not obtained any such information through the RTI Act, 2005 also. Attention is drawn to the list of such recommended candidates published by the PSC for the examination held in 2018. As per Mr. Ghosh, this list was published in the year 2020. Therefore, the point of limitation does
