The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 638-WBAT/2J-15/2016 (Pt.-II) dated 23rd November, 2022 issued in exercise of the powers conferred under Section 5 (6) of the Administrative Tribunals Act, 1985.

On consent of the learned counsels for the contesting parties, the case is taken up for consideration sitting singly.

Affidavit of service filed, be kept with the record.

The applicants have prayed for setting aside their rejection orders, rejecting their candidature for promotion to the post of A.S.I. under W.B.P. (Armed & Unarmed). The applicants had appeared for a test for the promotional post of A.S.I. and were not considered successful. Attention is drawn to a copy of "Instructions for Writing the Report" during the examination. Submission is that despite adhering to the instructions and being given marks for report writing, their candidature was not considered. To understand how an applicant had violated such instructions, Mr. Banerjee shows a copy of a Report written by one of the applicants during the examination. It is seen that the Instructions clearly prohibits a candidate to write his name, roll number and address in the body of the report or anywhere else except in the title page of the evaluation paper. As seen from the papers shown by Mr. Banerjee, this applicant, Pradip Roy, has violated such instructions by writing his name on the bottom of the report he had written during the examination.

Mr. Roy agreeing this can be a violation of instructions for this applicant but many other applicants had not violated the instructions, therefore, it is necessary for the state respondents to present copies of their evaluation papers before this Tribunal.

Mr. Banerjee agrees that if such direction is given to the respondent authority, copies of answer scripts relating to report writing of the applicants will be presented before this Tribunal.

In view of the above submissions, let the Respondent No.3, Secretary, West Bengal Police Recruitment Board present copies of the reports written by the applicants during the examination for the promotion to the post of A.S.I. (Armed and Unarmed).

Let the matter appear with these reports under the heading Admission Hearing on **08.07.2024.**
