The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 638-WBAT/2J-15/2016 (Pt.-II) dated 23<sup>rd</sup> November, 2022 issued in exercise of the powers conferred under Section 5 (6) of the Administrative Tribunals Act, 1985.

On consent of the learned counsels for the contesting parties, the case is taken up for consideration sitting singly.

The prayer in this application is for a direction to the respondent authorities to re-fix the pay scale of the applicant after setting aside the impugned order dated 07.06.2018. The prayer also includes a direction for refund of the alleged overdrawn of Rs. 97,480/- . It appears from page 66 of the application that the office of the Principal Accountant General (A&E) West Bengal wrote to Block Medical Officer of Health, Jagadishpur Block Primary Health Centre, Bally on 07.06.2018 in which certain clarifications were asked for.

Mr.D.Karan, learned counsel for the applicant submits that on the basis of the Principal Accountant General's letter dated 07.06.2018, the respondent authority has already recovered Rs. 97,480/-. However, after such recovery and refixation, the pension proposal has not been resubmitted to the office of the Principal Accountant General (A&E) West Bengal against the letter dated 19.01.2022. Since such revised pension proposal has not been submitted to the Principal Accountant
