Mr. G.P. Banerjee, learned advocate for the State respondents submits, if directed, the respondent authorities will consider the matter regarding grant of compassionate appointment to the applicant in accordance with law.

Having heard learned advocates for the parties and considering the facts and circumstances of the case, the application is disposed of by directing the Deputy Director of Drugs Control, Siliguri Regional Division Office, Darjeeling, the respondent no. 3 to dispose of the application dated 19th October,
