The matter is taken up by the single Bench pursuant to the order contained in the Notification No. 118-WBAT/1E-08/2003 (Pt.-II) dated 11th February, 2022 issued in exercise of the powers conferred under section 6 (5) of the Administrative Tribunals Act, 1985.

In this application, Bela Banerjee, the applicant has prayed for several reliefs, the relevant portion of which is as under:

“ i) An order directing the respondents and each one of them and their men , agents and subordinates to consider the representations of the applicant dated 25. 06. 2021; 22. 07. 2021; 2. 8. 2021 and also the notice issued by her Learned Advocate dated 13. 9. 2021; 27. 09. 2021 as contained in Annexure E,F,G and H of the application.

ii) An order directing upon the respondents and each one of them and their men, agents and subordinates to accept the voluntary retirement of the applicant on and from 30th day of October, 2021.

iii) An order directing the respondents and each one of them and their men, agents and subordinates to release all arrears of salaries, provident fund, gratuity arrears of pension and other retiral benefits;”
