The matter is taken up by the single Bench pursuant to the order contained in the Notification No. 118-WBAT/1E-08/2003 (Pt.-II) dated 11th February, 2022 issued in exercise of the powers conferred under section 6(5) of the Administrative Tribunals Act, 1985.

As prayed for by Mr. Sekhar Mustaphi, learned advocate for the applicant, leave granted to add the Executive Engineer, P.W.(Roads) Directorate, - as respondent no. 8 as a party respondent by amending the cause title of the application in course of this day.

In this application, the applicants Ganesh Datta, Suren Barman, Abinash Barman, Samsuddin Mia, all casual daily rates workers, have prayed for certain reliefs, the relevant portion of which is as under:-

- "a) An order or direction do issue directing the respondents their agents and subordinates to pay the arrear salaries of 36 months to the applicants.
- b) An order or direction do issue directing the Respondents their agents and subordinates to pay the applicants of their arrear salaries of 36 months w.e.f. 01.03.2016 to 28.02.2019 in terms of order No. 2171-E/E-1/2M-67/2018 dated 17.09.2018 (Annexure 'A').
- c) An order or direction do issue directing the respondents to consider the matter and to pay all arrear dues to the applicants forthwith....".
