The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 638-WBAT/2J-15/2016 (Pt.-II) dated 23<sup>rd</sup> November, 2022 issued in exercise of the powers conferred under Section 5 (6) of the Administrative Tribunals Act, 1985.

On consent of the learned counsel and the learned Departmental representatives for the contesting parties, the case is taken up for consideration sitting singly.

The applicants are engaged as part time Sweepers-cum-water carrier working under Sub Divisional Land & Land Reforms Officer, Kurseong and Mirik. In this application and the representations filed earlier by them, they have requested for increasing their monthly remuneration in tune with the latest Notification covering such remuneration. Memo. No. 7284-F(P<sub>2</sub>) dated 27.11.2017 has been presented before this Tribunal as the latest Government Order covering monthly remuneration of Rs. 2,000/- has now been enhanced to Rs. 3000/- per month with effect from 01.01.2018. Submission of Mrs.Agarwal, learned counsel is that the concerned respondent authorities may be directed to give effect of such remuneration by this Notification to the applicants.
