The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 118-WBAT/1E-08/2003 (Pt. - II) dated 11th February, 2022 issued in exercise of the powers conferred under Section 6(5) of the Administrative Tribunals Act, 1985.

With the consent of all the parties, the matter has been taken up for hearing.

The counsel for the applicant today has submitted that as per the letter dated 08.03.2022, the applicant has already sent four copies of specimen signature in separate sheets to the Executive Engineer, P. W. D., Diamond Harbour Division though post on 21.03.2022. The Departmental representative for the Pr. A.G. (A & E), West Bengal has submitted that unless and until the concerned department would comply with the observation made in the letter dated 08.03.2022, they are not in a position to make payment of family pension to the applicant. However, the counsel for the respondent has submitted that he has no instruction from the department in this regard.

Heard the parties and perused the records. It is noted that vide Memo dated 08.03.2022 Senior Accounts Officer / Pen.XII had asked for certain documents. which are as follows:

clarifications/documents/compliance of observation as detailed below:

- (a) Sanction for family pension in favour of Smt. Karuna Pandit in Annexure – III may please be furnished.
- (b) In terms of Rule 7(I)(e)(2) of WBS (DCRB) Rules-1971, dependant parents are eligible for family pension. Hence a certificate may be issued by Pension Sanctioning Authority if her income ceiling for (dependent) for the purpose of family pension is below Rs. 9000/- p.m.in accordance with the G.O. no. 270-F(Pen) dt. 08/09/2021.
- (c) Four copies of specimen signature of the incumbent in four separate sheet may be furnished.

II) Pension papers / Sr. Book of LATE PRASANTA KUMAR PANDIT is returned herewith, with the request to resubmit the same along with the above documents / information, to finalize the pension case.

III) Kindly quote the pensioner file id. No. 1200305712 while resubmitting Pension papers and for all future correspondence."

From the perusal of the above, it is noted that the concerned department has to supply or comply with the observation with regard to item No. (a) & (b), whereas the incumbent has to furnish four copies of specimen signature in four separate sheets before the authority and which he had sent it to the Executive
