The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 638-WBAT/2J-15/2016 (Pt.-II) dated 23<sup>rd</sup> November, 2022 issued in exercise of the powers conferred under Section 5 (6) of the Administrative Tribunals Act, 1985.

On consent of the learned counsels for the contesting parties, the case is taken up for consideration sitting singly.

The applicant has prayed for a direction to the respondent authorities to take a decision on the basis of his representation. A representation was filed by the applicant before the Chairman, West Bengal Police Recruitment Board dated 17.05.2022. It appears from the reply to the R.T.I. dated 26.05.2022, the applicant was informed that he could not submit the revalidated/ renewed OBC-A certificate during the interview which was held on 10.03.2022. It appears from page No. 29 in this application that one OBC-NCL Certificate Format was issued to the applicant on 26.04.2022.

Submission of Mr.M.N.Roy, learned counsel for the State respondents is that in the advertisement, it was clearly mentioned that any candidate belonging to OBC-A / B Category and if shortlisted for interview shall have to produce revalidated / renewed of fresh OBC- A / B certificate at the time of interview. Since no such certificate could be produced by the applicant at the time of interview, his candidature was not considered under OBC-A Category.

Appearing on behalf of the applicant, Sk.R.Alam, learned counsel for the applicant without controverting the facts, however relies and refers to a
