- ii) an affidavit of service annexing the copy of the aforesaid forwarding letter, original postal receipts, delivery status downloaded from the official website of the India post (<https://indiapost.gov.in>), in case of service through post, whereas in the event of direct service, the original receipted copy or copies of the forwarding letter/ letters bearing seal and signature of the receiving staff of the respondents, shall be produced on the next date.

In the case of compliance of the aforesaid direction under clause (i) above, the respondents are directed to be present either through the learned advocate, and or, in person on the next date before the Hon'ble 1st Single Bench in view of the urgency as stated in the said application and submission of the learned Counsel of the applicant.
