The present application in terms of section 19 of the Administrative Tribunals Act, 1985 inter alia praying for a direction to release the applicant from service of the respondent No. 4 on lien has been filed to secure redressal of grievances.

The learned counsel for the applicant submits that the case is extremely urgent, for which, the matter is required to be placed before the Bench for consideration of the interim relief, otherwise, the entire application will become infructuous.

Perused the application along with all annexure hereinafter referred to as the “said application”.

Considering the nature of substantive and interim relief as prayed for, the said application is required to be served upon the respondents to enable them to controvert the allegations, and or, statements made therein.

- ii) an affidavit of service annexing the copy of the aforesaid forwarding letter, original postal receipts, delivery status downloaded from the official website of the India post (<https://indiapost.gov.in>), in case of service through post, whereas in the event of direct service, the original receipted copy or copies of the forwarding letter/ letters bearing seal and signature of the receiving staff of the respondents, shall be produced on the next date.

In the case of compliance of the aforesaid direction under clause (i) above, the respondents are directed to be present either through the learned advocate, and or, in person on the next date before **the Hon'ble 1st Single Bench** in view of the urgency as stated in the said application and submission of the learned Counsel of the applicant.

The office is directed to upload the order passed today on the official website of the Tribunal (<https://wbato.gov.in>).

Accordingly, the next date is fixed on **28th February, 2022** for compliance of the above directions by filing an affidavit of service, and appearance of the respondents before the Hon'ble 1st Single Bench.

The Office is directed to enlist the matter in the daily cause list dated 28th February, 2022 under the heading "Admission Hearing" for consideration of the interim relief.
