The applicant has prayed for compassionate employment in this application after the death of his mother on 30.09.2020. The mother had worked as a Hostel Cook (Group-D) in Jalapiguri Government Engineering College. After the death of his mother, the applicant submitted an application for compassionate employment before the Principal on 30.03.2022. The Principal in turn sought for a guidance on this matter from the Director of Technical Education. Although, the applicant submitted a plain paper application for compassionate employment attaching relevant documents pertaining to the deceased mother, however, the respondents have not processed the case till today. The letter addressed to the Director by the Principal on 04.04.2022 has

also not been considered and any suitable advise communicated to the Principal.

Mrs. S.Agarwal, prays for a direction to the respondent No. 2 (iii), the Director of Technical Education, Department of Technical Education and Skill Development.

After hearing the submissions of the learned counsels, the application is disposed of by directing the respondent No. 2 (iii), the Director of Technical Education to consider the case of compassionate employment of the applicant as per rule and eligibility and issue necessary advise to the Principal, Jalpaiguri Government Engineering College within a period of eight weeks from the date of communication of this order.

Be it noted that the Tribunal has not gone into the merits of the case and all facts are left open for the respondent authority to deal and decide.

Accordingly, the application is disposed of.
