The matter is taken up by the single Bench pursuant to the order contained in the Notification No. 118-WBAT/1E-08/2003 (Pt.-II) dated 11th February, 2022 issued in exercise of the powers conferred under section 6 (5) of the Administrative Tribunals Act, 1985.

In this application, Dr. Nirmal Kumar Saha, the applicant has prayed for certain reliefs, the relevant portion of which is as under:

- "....a) Directing the respondents and/or their subordinates to award and/or give effect 16 (sixteen) years benefit under the carrier Advancement scheme of W.B.H.S. in favour of the petitioner forthwith and also to award subsequent 25 (twenty five) years benefit to the petitioner along with all financial benefit accordingly.
- b) Directing the respondents and/or their subordinates to make payment arrear in salary for the period from 23.08.2006 to 31.12.2019 amount of Rs.1001696/- with interest to the petitioner forthwith;
- c) Directing the respondents and/or their subordinates to release the arrear in salary to the petitioner for the period of 23.08.2006 to 31.12.2019 amount of Rs.1001696/- with interest on the basis of the statement of arrear bill uploaded in the name of the petitioner being I.D. No. 1990005363 and to give financial benefit after awarding 16 (sixteen) and 25 (twenty five) years service benefit to the petitioner forthwith...."
