The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 638-WBAT/2J-15/2016 (Pt.-II) dated 23<sup>rd</sup> November, 2022 issued in exercise of the powers conferred under Section 5(6) of the Administrative Tribunals Act, 1985.

The prayer in this application is for a direction to the respondent authorities to give marks to the applicant in respect of question Nos. 5, 27, 43, 51, 61, 65, 86, 95 and 98. The applicant had appeared as a candidate for recruitment to the post of Lecturer in Civil Engineering in Government Polytechnics conducted by Public Service Commission, West Bengal. Since his name was not considered as a successful candidate for interview, therefore, this application was filed contesting the correctness of the answer to question Nos. 5, 27, 43, 51, 61, 65, 86, 95 and 98 given by the Commission.

Mr. Bhattacharjee, learned counsel appearing for the Commission submits that as stated in paragraph 7 of the reply, the Commission after revaluation of question Nos. 5, 27, 43, 51, 61, 65, 86, 95 and 98 has now revised the marks obtained by the applicant in the Preliminary Screening Test. Earlier marks given to the applicant 63.67 has now been upgraded to 71.67. As a result, he now qualifies for the interview since his revised marks are above the last candidate called for interview under the UR category to which the applicant belongs.

Submission of the learned counsels of all the sides is that since the prayers in this application have now been fulfilled, this application may be disposed of.
