The matter is taken up by the single Bench pursuant to the order contained in the Notification No. 496-WBAT/1E-08/2003 (Pt.-II) dated 4<sup>th</sup> August, 2022 issued in exercise of the powers conferred under section 6 (5) of the Administrative Tribunals Act, 1985.

In the application, Susanta Ghosal, the applicant, a Research Officer under the Directorate of Agriculture has prayed for certain reliefs, the relevant portion of which is as under :

*“.....(i) Order/direction may be issued directing the respondent concerned, their men and gent and particularly the respondent No.2 to consider the representation made by the applicant for his equivalent notional benefits similar to the other employee from the same panel of the applicant whose service have been effected from the year 2000 on the rudiment that the applicant is/was not at all at fault for his resumption/appointment in the year 2011.*

*(ii) Order/direction upon the respondents to all the applicant with all notional benefits along with al pensionary benefits assuming that the applicant is in regular service since 2000 when his batchmates, whose name appeared in the same panel, were given appointed.*

*(iii) Order/direction upon the respondents to review and/or refix the salary of the applicant from the date of his deemed appointment in the year 2000.*

*(iv) An order/direction may be issued directing the respondent concerned and/or one of them to act and proceed strictly in accordance with law and/or pass such other or further order or orders as to Your Lordship may deem*

*(v) An order/direction on the part of the respondent authorities to consider the representation dated 25.03.2019 filed by the applicant.”*

Having heard learned advocates for the parties and considering the facts and circumstances of the case, the application is disposed of by directing the Director of Agriculture & Ex-Officio Secretary, Government of West Bengal, Kolkata, the respondent no. 2 to dispose of the representation dated 25<sup>th</sup> March, 2019 by passing a reasoned order to be communicated to the parties within fifteen weeks from the date of presentation of a copy of this order downloaded from the website of the Tribunal after giving an opportunity of hearing and after verifying the records.
