The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 638-WBAT/2J-15/2016 (Pt.-II) dated 23rd November, 2022 issued in exercise of the powers conferred under Section 5 (6) of the Administrative Tribunals Act, 1985.

On consent of the learned counsels for the contesting parties, the case is taken up for consideration sitting singly.

The applicant has prayed for an employment under the compassionate ground after the death of her father - Dasarath Pariyar, who had died on 23.03.2015 while working as a Field Assistant in Small Sericulture Demonstration Farm, Nimbong, Kalimpong Sub-Division. The applicant had submitted both plain paper application and proforma application before the Assistant Director of Sericulture on 20.07.2015. From the copy of Memo. dated 13.09.2023, it is seen that the Assistant Director and Joint Director of Sericulture (I/C) North Zone, Siliguri had forwarded to the Commissioner, Directorate of Sericulture, the proposal along with relevant documents. Submission of Mrs.Das is that despite such submission, the respondent authority has not taken any decision. Mr.Banerjee, learned counsel appearing on behalf of the State respondents submits that if a direction is given, the same will be complied as per rules.
