The matter is taken up by the single Bench pursuant to the order contained in the Notification No. 118-WBAT/1E-08/2003 (Pt.-II) dated 11<sup>th</sup> February, 2022 issued in exercise of the powers conferred under section 6 (5) of the Administrative Tribunals Act, 1985.

In this application, Golam Mohiuddin Bora – the applicant, who had superannuated as an Assistant Inspector of Schools (Primary Education), Uttar Dinajpur on 31<sup>st</sup> December, 2013, has prayed for an order directing the respondent authorities to disburse the leave salary, Group Insurance and 25 years service benefit as per G.O. No.-10580-F(P) dated 28<sup>th</sup> December, 2012.

It is submitted by Mr. W. A. Mondal, learned advocate for the applicant that during the pendency of the original application, the respondent authorities have given the service benefit as per G.O. No.-10580-F(P) dated 28<sup>th</sup> December, 2012 pursuant to the order of the Tribunal passed in O.A. No. 389 of 2016, by Office Memorandum dated 13<sup>th</sup> April, 2018 issued by the Commissioner of School Education, West Bengal –the respondent no. 2. Thereafter, money under the same benefit has been given and the amount has been disbursed. However, till date, leave salary and Group Insurance are yet to be released. Submission is the respondent no. 2 may be directed to issue necessary orders for grant of leave salary and Group Insurance along with interest for delayed

Having heard the learned advocates for the parties and considering the facts and circumstances of the case, the application is disposed of by granting liberty to the applicant to file application praying for grant of leave salary and Group Insurance along with interest before the Commissioner of School Education, West Bengal –the respondent no. 2 within four weeks along with a copy of this order downloaded from the website of the Tribunal. If representation is filed within the time as stipulated praying for grant of disbursement of leave salary and Group Insurance along with interest on delayed payment, if any, same shall be disposed of by the respondent no. 2, by passing a reasoned order to be communicated to the parties within eight weeks.
