The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 118-WBAT/1E-08/2003 (Pt.-II) dated 11<sup>th</sup> February, 2022 issued in exercise of the powers conferred under Section 6 (5) of the Administrative Tribunals Act, 1985.

suffice his purpose if the Additional Chief Secretary, Panchayet & Rural Development Department BE directed to take a final decision with regard to compassionate appointment of the applicant within a stipulated period of time.

In view of the above, Additional Chief Secretary, Panchayet & Rural Development Department is directed to take a final decision with regard to compassionate appointment of the applicant and communicate the same by way of passing a speaking and reasoned order within a period of four months from the date of receipt of the order. Accordingly, OA is disposed of with no order as to costs.

Since the circumstances beyond control, the Registry is unable to furnish plain copies of this order to the learned advocates for the parties, the Registry is directed to upload this order on the website of the Tribunal forthwith and parties are directed to act on the copies of the order downloaded from the website.
