The instant application has been filed mainly praying for a direction upon the respondents to enhance the remuneration of the applicant in terms of order dated 16.09.2011 & 25.02.2016.

As per the applicant, he was engaged as part time sweeper-cumwater carrier as casual worker since 01.01.1980. However, his remuneration has not been enhanced till date. It has been further submitted that the applicant along with others had made representation before the authority on 20.06.2017. However, no action has been taken.

During the course of hearing, the counsel for the applicant has submitted that it would suffice his purpose if the Respondent No. 1 be directed to consider his case in the light of the circulars mentioned above and disburse the enhanced remuneration within a stipulated period of time.

The counsel for the respondent has no objection to consider the representation of the applicant in the light of the aforementioned circulars.

Heard both the parties and perused the records.

In view of the above, the Secretary, Food & Supplies Department, Govt. Of West Bengal is directed to consider the case of the applicant in the light of the aforementioned G.O.s and to take a final decision by way of speaking and reasoned order within a period of eight weeks from the date of receipt of the order. Accordingly, OA is disposed of.
