Mr. G. P. Banerjee, learned advocate for the State respondents adopts the submission of Mr. Basu.

Having heard learned advocates for the parties, since the interview process has started, let the interview be concluded and within a week thereafter, the Public Service Commission, West Bengal – the respondent no. 3, shall publish the marks obtained by each candidate, including the applicant, in the written test as well as in the interview separately for the sake of transparency. It is made clear that the interview process shall proceed according to the schedule. It is also made clear that no appointment letter be issued and no appointment be made without the leave of the Tribunal.

As prayed for by Mr. Basu, let reply be filed by the respondents by 10<sup>th</sup> September, 2021. Rejoinder, if any, by 24<sup>th</sup> September, 2021. Let the matter appear under the heading "To be Mentioned" on 1<sup>st</sup> October, 2021.
