Mr. S. Ghosh, learned advocate for the applicant submits that in view of the submission of Mr. Roy, appropriate order may be passed.

Since the applicant has been transferred from Howrah (Rural) District to Purba Medinipur by order dated 22nd May, 2017 and since it is submitted on behalf of the respondents that the order of transfer could not be carried out due to unavoidable circumstances, considering the facts and circumstances of the case, the original application is disposed of by directing the Superintendent of Police, Howrah (Rural) District, Paniarah Police Line, – the respondent no. 3, to issue necessary release order for transfer of the applicant from Howrah (Rural) District to Purba Medinipur within a period of eight weeks from the date of presentation of a copy of this order downloaded from the website of the Tribunal.
