The matter is taken up by the single Bench pursuant to the order contained in the Notification No. 118-WBAT/1E-08/2003 (Pt.-II) dated 11<sup>th</sup> February, 2022 issued in exercise of the powers conferred under section 6 (5) of the Administrative Tribunals Act, 1985.

In this case, the petitioner – Asoke Bhakat has prayed for certain reliefs, the relevant portion are as hereunder:-

- "(a) An order do issue by setting aside the reasoned order dated 14.06.2021 being Annexure "A-6" with immediate effect.
- (b) An order do issue by directing the respondents Principal Secretary to issue the necessary order to the concerned department by releasing the pension benefit of the applicant. Further more papers be sent to the respondent No. 5 being the Principal Accountant General (A & E, West Bengal) to release the pension alongwith all arrears in favour of the applicant forthwith."

The petitioner – Asoke Bhakat worked as Work Asst. in the Public Works Department and superannuated on 29<sup>th</sup> February, 2020. The petitioner prays for release of retirement benefits which has not yet been considered on the ground that he has a shortfall of 35 days service to

qualify for getting pension. The prayer is for condonation of these 35 days. Earlier on 7<sup>th</sup> December, 2020 in OA-318 of 2020: Asoke Bhakat –Vs- The State of West Bengal & Others, the Tribunal had directed the Principal Secretary, Public Works Department, Government of West Bengal to dispose of the prayer of the application with a reasoned order. Pursuant to the Tribunal's direction, the Additional Chief Secretary, Public Works Department, Government of West Bengal considered the matter and referring to the Finance Department's opinion had rejected the petition citing WBS(DCRB) Rules, 1971, the relevant portion of the reasoned order is as follows:-

"In the light of the abovementioned facts and circumstances, the legal provisions and the Order passed by The Hon'ble West Bengal Administrative Tribunal, the point to be decided is whether the deficiency of 35 Days could be considered or not. In this regard, views of Finance Department, Government of West Bengal was solicited. Finance Department in their decision conveyed on 26/04/2021 have affirmed that in terms of WBS(DCRB) Rules 1971, shortfall of six months may be condoned by the State Government in case of invalid and compensation pension only and since the case of Sri Bhakat is not one of invalid and compensation pension, the shortfall of 35 days in his qualifying service cannot be condoned, in accordance with extant govt. rules.

3. Decision: After going through the facts and circumstances of the case and after perusal of relevant records placed before me, it is found that shortfall of 35 days in qualifying service cannot be condoned, in the present case as per the extant govt. rules."
