The matter is taken up by the single Bench pursuant to the Notification No. 949-WBAT/2J-15/2016 dated 24th December, 2020 issued in exercise of the powers conferred under sub section (6) of section 5 of the Administrative Tribunals Act, 1985.

Let affidavit of service filed today be kept on record.

As prayed for by Mr. G. P. Banerjee, learned advocate for the applicant leave granted to make necessary correction in the cause title relating to respondent no. 1 and paragraph 4 of the application.

In this application, Disha Chakraborty (Bhattacharya), the applicant, has prayed for a direction upon the respondents to grant appointment on compassionate ground in died-in-harness category due to the death of her father –Dinesh Chakraborty - Ex-draftsman, Ex-Officio SAE in the Land Acquisition Department, South 24-Parganas Collectorate, Alipore (L & L. R. Department) on 15th February, 2001. It appears Dinesh Chakraborty had expired leaving behind two unmarried daughters Disha Chakraborty and Dina Chakraborty. With the passage of time both daughters have got married. Now the applicant, one of the daughters of the deceased employee, is praying for appointment. It

appears the applicant had filed an application for employment in died-inharness category in July, 2001 and thereafter a representation appearing at page 29 of the application was filed before the District Magistrate and Collector, South 24 Parganas, Alipore, Government of West Bengal –the respondent no. 3 praying for employment. Prayer is a direction be issued upon the respondents to consider the same.

Heard Mr. G. P. Banerjee, learned advocate for the applicant and Mr. A. Datta, the Departmental Representative for the State respondents.

Having heard the learned advocates for the parties and considering the facts and circumstances of the case, the application is disposed of by directing the Principal Secretary, Land and Land Reforms Department, Government of West Bengal – the respondent no. 1, to dispose of the representation for appointment in the died-in-harness category, appearing at page 29 of the application, by passing a reasoned order to be communicated to the parties within 15 weeks from the date of presentation of a copy of this order downloaded from the internet after giving an opportunity of hearing to the applicant, Dina Chakraborty and also to Doly Chakraborti, the mother of the applicant, and on the basis of the orders and notifications prevalent on the date of death of the father of the applicant.
