The matter is taken up by the single Bench pursuant to the order contained in the Notification No. 118-WBAT/1E-08/2003 (Pt.-II) dated 11th February, 2022 issued in exercise of the powers conferred under section 6 (5) of the Administrative Tribunals Act, 1985.

In this application, Bhanu Kumar Saha - the applicant, who had superannuated on 30th June, 2017 as Assistant Sub-Inspector (AB) has prayed for certain reliefs, the relevant portion of which is as under:-

"(a) An order directing the respondents, their men, agents, servants and / or assignees to pay all due service benefits of the applicant on account of promotion dated 22.02.2012 as an Assistant Sub-Inspector (AB) under the control of the respondents forthwith upon considering his representation dated 12.02.2021 being Annexure-"E" to this application.

(b) An order directing the respondents to consider and dispose of the representation dated 12.02.2021 being Annexure-"E" to this application in accordance with law forthwith."

It is submitted by Mr. A. K. Das Sinha, learned advocate for the applicant that though the applicant, is drawing pension however consequential promotional benefits have not been given. Though letter

dated 5th March, 2021 demanding justice was furnished before the Director General of Police, West Bengal, Police Directorate and the Deputy Commissioner of Police, Headquarter, Howrah Police Commissionerate, Howrah – the respondent nos. -2 and 6 respectively, no action has been taken. Aggrieved this application has been filed.

Mr. B.P. Roy, learned advocate for the State respondents submits, if directed, the respondents will consider the matter in accordance with law.

Having heard the learned advocates for the parties and considering the facts and circumstances of the case, the application is disposed of by granting liberty to the applicant to file a representation ventilating his grievances, annexing copies of relevant documents particularly with regard to his promotion to the post of Assistant Sub-Inspector (AB) before the Deputy Commissioner of Police, Headquarter, Howrah Police Commissionerate, Howrah – the respondent no. – 6 along with a copy of this order downloaded from the website of the Tribunal within eight weeks. If representation is filed within the time as stipulated, the respondent no. 6 shall dispose of the same by passing a reasoned order to be communicated to the parties within eight weeks after giving an opportunity of hearing, after verifying the records and after making necessary enquiry.
