The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 118-WBAT/1E-08/2003 (Pt.-II) dated 11<sup>th</sup> February, 2022 issued in exercise of the powers conferred under Section 6 (5) of the Administrative Tribunals Act, 1985.

On consent of the learned counsel for the petitioner, matter has been taken up for hearing.

The counsel for the applicant today has submitted that the instant application was heard along with OA-758 of 2018 on 06.02.2020. In OA-758 of 2018, the applicant had asked for retiral benefits of her father and in the instant application, she had asked for compassionate appointment. As per the counsel for the applicant, both the OAs were disposed on 06.02.2020. However, in the instant application, though in her prayer, she has prayed for direction for compassionate appointment, however, the order dated 06.02.2020 in the 3<sup>rd</sup> line as well 20<sup>th</sup> line of order dated 06.02.2020 inadvertently retirement benefit had been typed in place of compassionate appointment. Therefore, she has prayed for necessary correction in the order dated 06.02.2020.

The departmental representatives have no objection to such proposition.

Heard the parties and perused the records. It is noted in the prayer of the instant application, the applicant has prayed for compassionate appointment, therefore, in the 3<sup>rd</sup> line and 20<sup>th</sup> line of order dated 06.02.2020, compassionate appointment should be substituted in place of retirement benefit.
