The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 638 – WBAT / 2J-15/2016 dated 23rd November, 2022 issued in exercise of the powers conferred under Section 5(6) of the Administrative Tribunals Act, 1985.

Mrs. S. Mitra, learned counsel for the applicant prays for time to serve the copy of the application to the State respondents.

The applicant has filed this application praying for a direction to the respondent authorities to accept her letter of resignation dated 13.05.2024. Such letter of resignation was submitted before the Director of Medical Education in the prescribed proforma. Mr. Banerjee and Mrs. Mitra, learned counsels for the respondent authorities submit that no decision has been yet taken by the respondent authorities in this matter.

Mr. Ghosh and Mr. Roy, learned counsels for the applicant has submitted that it's been more than four months since such resignation letter was furnished before the respondent authorities and they are sitting tight over it. Their submission is that it would suffice if a direction be given to the respondent authorities to consider her letter of resignation.

Mr. Banerjee and Mrs. Mitra, learned counsels submit, if such a direction is given, the same will be complied as per rules. Given the fact that the applicant who holding the post of Assistant Professor in the Department of Obstetrics & Gynaecology had furnished her letter of resignation before the Principal Secretary and Director of Medical Education and since no decision has been taken it is imperative that the Tribunal directs the respondent no. 3, Director of Medical Education, Department of Health & Family Welfare to consider the letter of resignation dated 13.05.2024
