2019 have been filed for restoration of the writ applications which were dismissed for default, but the said CAN applications have not yet been listed for hearing.

Mr. Karim representing the applicants submits that the contempt application can be taken up for hearing, as the writ applications filed by the state respondents have already been dismissed for default.

Since the state respondents have taken steps for restoration of the writ applications which were dismissed for default and by which the state respondents challenged the order passed by the Tribunal, the judicial propriety demands that we should wait for reasonable period of time before proceeding with the hearing of contempt application.

Under the above circumstances, both parties are directed to intimate the Bench about the result of CAN applications filed by the state respondents before the Hon'ble High Court.
