applicable in the present case.

Accordingly, we set aside the Memo No. PHE/Estt/1931/2E-22/2011 dated August 13, 2015 issued by the Special Secretary, Department of Public Health Engineering and now direct the Secretary, Department of Public Health Engineering, Government of West Bengal to take a decision on the prayer for compassionate appointment made by the applicant within a period of 12 (twelve) weeks from the date of receipt of this order.

Before he arrives at his finding, he will give an opportunity of hearing to the applicant. Needless to say that while taking a decision, the Secretary, Department of Public Health Engineering, Government of West Bengal will not take into account the delay factor, which we have already decided."

It appears from the above order of the Tribunal that the contemnor should have taken decision on prayer of the applicant for compassionate appointment on the basis of report submitted by the enquiry committee and in accordance with Notification No. 97-EMP dated June 06, 2015 issued by the Labour Department, Government of West Bengal, which was in force at the time of death of the concerned employee. On perusal of the compliance report submitted by the contemnor and on consideration of the reasoned order passed by the contemnor (Annexure

O2 to the objection against compliance report of the contemnor), we find that the contemnor has rejected prayer of the applicant for compassionate appointment on the ground of delay, though the Tribunal specifically directed the contemnor not to take into account delay factor in deciding the fate of the application for compassionate appointment in the instant case. It is true that prime consideration for compassionate appointment is the need of immediate financial crisis in the family of the deceased employee. The report of three men enquiry committee was available in this regard as reflected from the order of the Tribunal, but the same has not been considered by the contemnor. Nor the contemnor has considered the application for compassionate appointment in accordance with the provisions of Notification No. 97-Emp. dated June 6, 2005 issued by the Labour Department, Government of West Bengal. In our view the contemnor has failed to comply with the direction of the Tribunal either by passing reasoned order or by submitting compliance report. Accordingly, the compliance report submitted by the contemnor cannot be accepted by the Tribunal.

We would like to grant the last opportunity to the contemnor to comply with the direction of the Tribunal within a period of 8 (eight) weeks from the date of
