into force of the amended recruitment rules. Such order is to be passed within a period of 12 (twelve) weeks from the date of communication of this judgment and the same is to be communicated to the applicants immediately thereafter."

The compliance report submitted on behalf of the contemnor on September 18, 2017 indicates that the Finance Department has not given the benefit of scale to the applicant at par with that of the Librarians of ATI on consideration of volume of work and nature of duty performed by the Librarians of ATI. The Tribunal gave direction for taking a decision on behalf of the contemnor in the light of amended recruitment rules. The compliance report does not indicate that the contemnor has taken into consideration amended recruitment rules for coming to the conclusion that the applicant is not entitled to get benefit of scale of pay applicable to the Librarians of ATI.

Under such circumstances, we are inclined to give another opportunity to the contemnor to comply with the direction passed by the Tribunal. So the compliance report submitted by the contemnor is not accepted by us.

The contemnor is directed to comply with the direction of the Tribunal within a period of 12 (twelve) weeks from this date.
