Compliance Report submitted on behalf of the contemnor in the sealed cover today is kept on record. On scrutiny of the compliance report, it appears that the contemnor is supposed to take steps for issuance of sanction order for pension and other retiral benefits of the government employee after passing of final order in the disciplinary proceeding pending against the said concerned employee in terms of direction given by the Tribunal on February 17, 2016 in OA-784/2015.

It appears from the compliance report that the disciplinary proceeding pending against the employee Jawaharlal Chatterjee is over and he died on September 27, 2017. With regard to the steps to be taken by the contemnor for release of retiral benefits to the wife of the deceased employee, we find that the order of family pension has already been issued in favour of wife of the deceased employee and the copy of the same was received by Smt Sagarika Chatterjee on November 30,
