Principal Secretary to the Government of West Bengal, Department of Food & Supplies to take a decision on the basis of prayer of the application and consider whether the ratio of the decision of the Tribunal in "West Bengal Subordinate Food & Supplies Service Association & Ors. Versus The State of West Bengal & Ors." (OA-812 of 2013 disposed of on July 13, 2015) is applicable in order to enjoy them the same benefit.

Mr. G.P. Banerjee, Learned Counsel representing the contemnor has produced copy of order dated January 15, 2019 issued by the contemnor and the same is kept on record. It appears from the said reasoned order that the applicants deserve to be treated similarly as other Inspectors of the Department of Food & Supplies, who are enjoying scale no. 10, but the Principal Secretary had no other option than to refer the matter the 6<sup>th</sup> Pay Commission for recommendation for grant of pay scale no. 10 to all Inspectors of Food & Supplies Department as the Finance Department has already requested for referring the matter to the 6<sup>th</sup> Pay Commission. On perusal of the reasoned order, we are of the view that the contemnor has complied with the direction of the Tribunal, though the applicants have not got the benefit of scale no. 10.

In view of our above observation, the contempt application stands **disposed of.**
