It appears from the said order dated December 18, 2015 that the Tribunal gave direction to the Chief Medical Officer of Health, Purba Medinipur to consider the prayer of the applicant claiming for family pension and to take a decision in accordance with rules within a period of three (3) months from the date of communication of the order. It is contended on behalf of the applicant that the order of the Tribunal was communicated to the Chief Medical Officer of Health, Purba Medinipur initially on January 21, 2016 and thereafter on October 3, 2016.
